



## The Dr. Daniel L. Pilkinton Award for Outstanding Service to Public Education

### Criteria for Consideration

Dr. Daniel L. (Dr. Dan) Pilkinton, who passed away in 2009, was widely known throughout the state for his lifelong service to public education. He was closely linked to the Arkansas School Boards Association since its inception and was the association's first executive secretary. After his retirement, Dr. Dan served ASBA in many ways, particularly in the areas of state governmental affairs and legislation. In 1993 the ASBA Board of Directors voted to create the annual Dr. Daniel L. Pilkinton Award as a tribute to him and the fine work he performed for public education in Arkansas.

#### **Nomination criteria:**

1. Nominee should have made a significant contribution to public education in Arkansas through meritorious service in roles such as school board member, administrator, teacher, school attorney, other school employee, legislator, elected official or school patron.
2. Nomination may relate to a singular experience in one year or cumulative experiences over a period of years. Nominations may be valid for up to three years after submission.
3. Nominations may be made by Arkansas school boards that are ASBA members, the superintendent of an ASBA-member district or by individual school board members.

#### **Nomination submission information:**

1. The nomination form should be completed to the extent possible, including the name of the nominee, the contributions upon which the nomination is based and any supporting data relative to the nominee and his/her qualifications for the award.
2. **Nomination deadline is November 2.**
